CTA Right to Use

For any communication product which appears in a media outlet, I specifically authorize CTA to have the right of reasonable usage of such product for any organizational purpose. Upon request, I will provide a copy of such product to CTA.

Process for Written Permission for Usage

Acknowledgement of process for written permission for usage or transfer of communication product.

I acknowledge that:

- for use at any other outlet than that described above, written permission of Call To Action is required.
- if film or other communication product (photos, audio, video, electronic, written or other descriptive or interpretive product) is being prepared buy a specific buyer or outlet is not yet committed or identified as described above, it is my obligation to notify CTA in writing on the attached form of an intent to enter into an agreement to provide such film or production materials, and to receive written permission from CTA for such use prior to the delivery of such film or communication product.
- I will maintain control of the film or other communication product and will hold CTA harmless against its transfer or delivery to another party and subsequent use without written permission of CTA, under the above obligations.

For any violation, Call To Action is entitled to recover its costs, including reasonable attorney’s fees, and other damages, beginning from the time of delivery of film or production material for which written permission has not been received, or the beginning of communications prepared by legal counsel concerning such potential delivery, or the institution of formal legal action, in the discretion of Call To Action.

I specifically authorize the filing of any legal action by Call To Action in the State of Illinois, Cook County, to enforce this agreement and any damages or other consequences concerning actions arising from violation of this agreement in participation as a member of the working media person at the Conference, and submit to jurisdiction of court in Cook County, Illinois with notice to me at the above address, or other such address as I shall provide to CTA.
